By getting involved you'll help us undertake our mission to educate people in Scotland about global issues through development education. This increases our capacity to provide a hand up to people in some of the world's poorest countries. We can't do it without you!



## **Role description**

#### Overall purpose of role

To support SCIAF's mission to provide quality and engaging development education in Scotland, driven by Gospel values.

#### Time commitment

Membership of the group will be for a term of 2 years, with an option to continue beyond that at the request of the Chair.

At a minimum, you will be required to attend 2 meetings per year. This will be a hybrid meeting (face-to-face in the SCIAF Office in Glasgow, and online) to allow for higher engagement of members from around Scotland.

#### **Tasks/Activities**

As a member of the Education Advisory Group you are expected to support and advise the Development Education Team.

#### Activities can include:

- Advising on the creation and development of the Development Education strategy
- Acting as an advocate for SCIAF's development education approach
- Providing feedback on current education resources and offering professional expertise
- Advising on future education resources, identifying new opportunities and trends
- Ensuring SCIAF is kept informed of major developments in the education sector in Scotland
- Creating links between SCIAF and communities within the education sector for whom our work has particular relevance
- Providing guidance and professional advice within the area of expertise you represent within the group.

#### Safeguarding

As an agency of the Catholic Church in Scotland, SCIAF's Safeguarding Policies and Procedures are guided by In God's Image, version 2: Instruction on Safeguarding in the Catholic Church in Scotland 2021.

SCIAF undertakes to ensure that all staff, volunteers and relevant others, whose work might involve contact with children, will have completed additional recruitment procedures and have obtained a satisfactory PVG Check from Disclosure Scotland.



#### **Code of Conduct**

All staff are expected to adhere to a Code of Conduct which specifies the attitudes and behaviour that all Caritas staff are expected to maintain. The Code is derived from, and closely related to, the Caritas Code of Ethics which prescribes the basic values and institutional practices of Caritas organisations.

"Individuals who care for those in need must first be professionally competent: they should be properly trained in what to do and how to do it, and committed to continuing care. Yet, while professional competence is a primary, fundamental requirement, it is not of itself sufficient. We are dealing with human beings, and human beings always need something more than technically proper care. They need humanity. They need heartfelt concern."

SCIAF invests in improving the skills of its volunteers and staff, and actively encourages everyone to broaden their understanding and knowledge through relevant training.

#### **Expenses**

Travel to and from Education Advisory Group meetings either by car or public transport will be reimbursed.
